

\$1000 IMPACT SCHOLARSHIP

American Business Women's Association (ABWA) has funded a scholarship in the amount of \$1,000 through the Stephen Bufton Memorial Educational Fund to be awarded to a deserving female student.

Each year, local chapters of ABWA provide Stephen Bufton Memorial Scholarships (SBMEF) to female students who will be attending accredited U.S. colleges, universities and community/vocational schools. Applicants for the \$1,000 Impact Scholarship must be citizens of the United States; residents of Brevard County; and enrolled in a licensed, accredited or state approved community college, technical or vocational school in August 2020 with a GPA of 2.5 or higher. Applications must be completed online at www.sbmef.org by May 30, 2020. A minimum of three (3) eligible completed applications are required for the scholarship to be awarded. The scholarship recipient will be notified in June 2020.

For over 60 years, ABWA has helped women achieve their business and professional success through educational scholarships. Since its inception, more than 17,000 women nationwide have been awarded more than 17 million dollars in scholarships.

The Stephen Bufton Memorial Educational Fund is a 501(c)3 charitable trust and public foundation. It has the same tax status as public schools, churches and community





Jennifer Snyder



Carol Atkinson is a licensed marriage and family therapist who has owned and managed private practices in Florida for nine years. Her professional background in social work, both child protection and mental health, created a solid foundation toward her career in social work education and training. She obtained her Masters in Social Work at Croydon College in Surrey, England, and her Masters in Health Science from London South Bank University.

Dr. Atkinson worked at Goldsmith's College, University of London, in various positions including practice teacher, practice assessor, practice teaching management committee member, and interviewing potential candidates for the social work programs, over a period of 10 years.

Health care reform in London made significant changes to the social work profession which no longer fit with Dr. Atkinson's philosophy for treating people, thereby prompting her transition to family therapy where she completed her PhD at Nova Southeastern University.

Dr. Atkinson worked as a classroom therapist with elementary school aged children in a day treatment program for children with

Born and raised in London, England, Dr. social, emotional and behavioral challenges. In the same organization, she managed a respite program for 'at risk' youth in Broward County, where she supervised a team of behavior technicians and other support workers. Her role as a therapist in a private practice inspired her to open her own practice. Since 2011, Dr. Atkinson has been in private practice.

> Her passion to create opportunities for change in people's lives on a holistic level inspired concepts to transform her clinical practice. Her desire to make a paradigm shift from the lens of psychopathology towards viewing people, relationships and systems through the lens of wellness, created new narratives, underscored her aspirations to explore fresh grounds, and thus shaped the emergence of service provision through a new set of lenses.
