



Kelley Higney

How does a successful and powerful woman navigate work, employee relationships, and life in general? An accomplished leader and entrepreneur, Kelly Higney will share her story and experiences in achieving success.

Kelley Higney is the founder and CEO of "Bug Bite Thing," the chemical-free, reusable insect bite relief suction tool that is Amazon's

Company Executive Board and Forbes Business Council, the recipient of many awards and was named "Female Entrepreneur of the Year" by the 2021 Stevie Awards for Women in Business.

both her mother and grandmother as entrepreneurs, Kelley was helping out with the family business, A.C. Kerman Inc., an international brokerage firm for the fishing and outdoor product industry. Whether it was attending trade shows in Las Vegas as a family regularly, or answering the phone at the office, Kelley was always working and learning.

In 2013, Kelley's family relocated to South Florida, where they were unprepared for the mosquitos. Kelley's six-month-old daughter was constantly suffering from severe reactions to the bites. Determined to find a natural alternative to the available remedies on

#1 selling insect bite treatment, with over the market, Kelley began conducting re-75,000 reviews. Kelley is a member of Fast search and discovered an unfamiliar product that uses suction to remove the irritant. In 2017, she secured exclusive distribution rights to the product and branded it "Bug Bite Thing."

The company gained national recognition Growing up in San Diego, California with in October 2019 when Kelley and her mother, Ellen McAlister, appeared on ABC's hit show, "Shark Tank." All the Sharks were biting with offers to invest in the business, but it was Lori Greiner's "Golden Ticket" offer that secured the partnership. In April 2021, Kelley and her mother returned to "Shark Tank," where they shared details on the company's transformation into a multi-million dollar enterprise.

Kelley is active within the South Florida business community, where she resides with her husband, Richard, and their daughters, Leah and Lilly.

In her life, Diana has found a love of public service and strives to make a difference in her community in as many meaningful ways as possible. This also meant following an academic path that would develop her institutional knowledge and enhance her leadership abilities in terms of service. She is currently pursuing a Doctorate in Public Administration with a concentration in Public Sector Management at Valdosta State University.

Her doctoral dissertation research is focused on a program evaluation for Family Promise of Brevard and conducting a statistical analysis on the data they've collected from their program while serving homeless

With a heart for community service and being raised by a single mother who was a role model for giving back to the community, Diana is always looking for opportunities to serve. Most of her extracurricular activities involve volunteering in Brevard County, including coordinating with Children's Hunger Project and Junior Achievement to pack meals for hungry children on weekends and teach financial literacy skills to students. She has also created the Galactic Fundraiser with her Rock Paper Simple (RPS) team, which raised over \$20,000 for 'You're the Key' addressing family homelessness, earned RPS a Gold Angel Award, given to a business that makes significant community impact. As Secretary (2 years) and Treasurer (1 year) of the Space Coast Field of Dreams board, as well as co-founder of the Canine Companions East Coast Chapter, Diana advocates for people with disabilities and accessibility needs within our community.


